

ADVERTISEMENT FOR BIDS

The Lynn Housing Authority, the Awarding Authority, invites sealed bids from Roofing Contractors for the replacement of the low-slope membrane roof assembly at a 3-story wood-frame residential building for the Lynn Housing Authority in Lynn, Massachusetts, in accordance with the documents prepared by the MA Dept. of Housing and Community Development.

The Project consists of: replacement of low-slope membrane roof assembly with new 3-ply modified bitumen roof assembly at a three-story residential building located at 72 Neptune St., Lynn, MA

The Work is estimated to cost \$29,000

Bids are subject to M.G.L. c.149 §44A-J & to minimum wage rates as required by M.G.L. c.149 §§26 to 27H inclusive.

General Bids will be received until 2:00 PM Wednesday, February 29, 2012 and publicly opened, forthwith.

All Bids should be sent to: Lynn Housing Authority, 92 Curwin Circle, Lynn, MA 01905 and received no later than the date & time specified above.

General bids shall be accompanied by a bid deposit that is not less than five (5%) of the greatest possible bid amount (considering all alternates), and made payable to BidDocs Online.

Bid Forms and Contract Documents will be available for pick-up at 9:00 A.M on 1 February 2012 at Nashoba Blue Printing, 433 Main St., Hudson, MA 01749. between the hours of: 8:30AM and 4:00PM- Monday through Friday.

There is a plan deposit of \$ 25per set (maximum of 2 sets) payable to BidDocs Online.

Deposits must be a certified or cashier's check. This deposit will be refunded for up to two sets for general bidders and for one set for sub-bidders upon return of the sets in good condition within thirty days of receipt of general bids. Otherwise the deposit shall be the property of the Awarding Authority.

Additional sets may be purchased for \$ 50

Bidders requesting Contract Documents to be mailed to them shall include a separate check for \$ 20 per set, in addition to the plan deposit; payable to the BidDocs Online, to cover mail handling costs. The \$20 mail and handling costs are non-refundable.

The job site and/or existing building will be available for inspection between 9:00 AM and 9:30 AM on February 15, 2012. Contractors visiting the site on that day should meet in front of building at 72 Neptune St.
